Dow Jones Sustainability Index

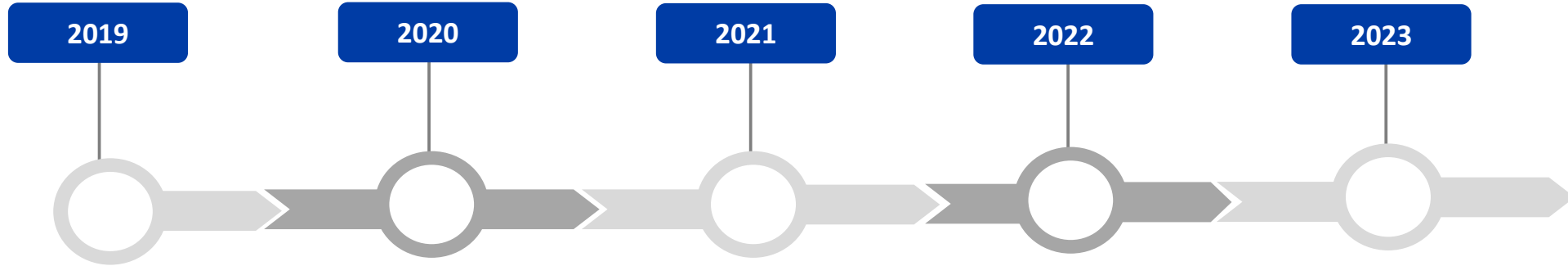

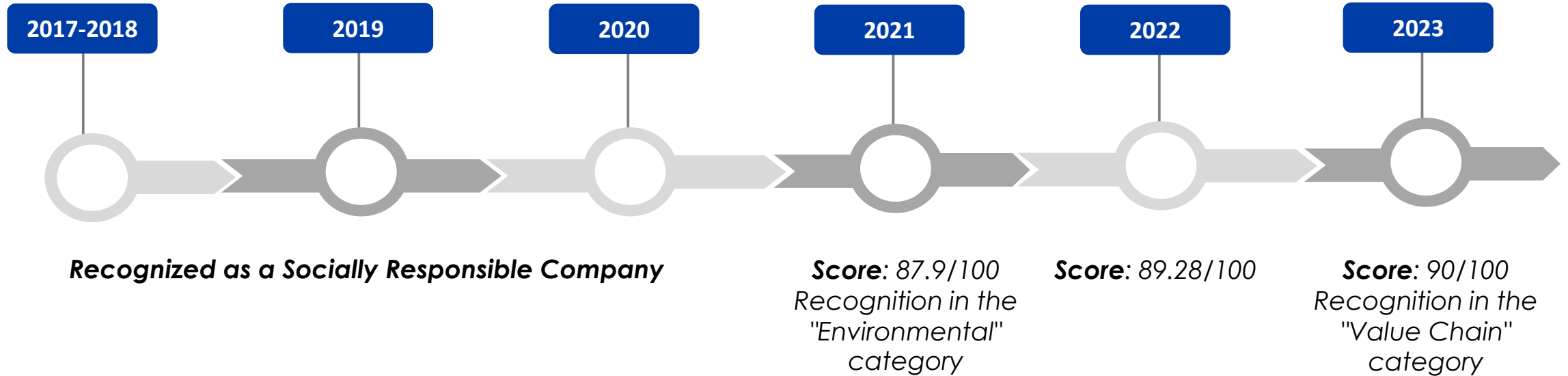

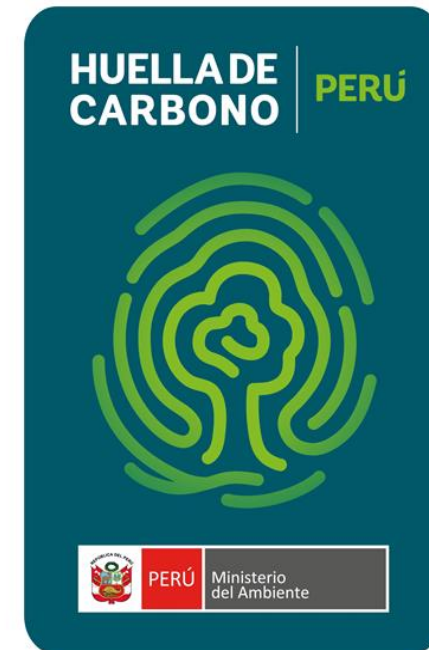


Carbon footprint



The Carbon Footprint Peru is a climate action tool promoted by the State, which recognizes the efforts of organizations to reduce their Greenhouse Gas (GHG) emissions. Since 2020, we have participated in the Carbon Footprint Peru Program with the 2019 inventory.

In 2023, we were one of the 10 companies in the manufacturing sector to be recognized.



Peru Limpio (MINAM))



In 2020, we were the first steel company to sign the Clean Production Agreement (APL) signed by the Ministry of the Environment and the Ministry of Production, committing to four specific goals:

- Valorization of metal waste in the production of liquid steel.
- Utilization of industrial by-products in CAASA.
- Implement actions to increase the valorization of solid waste.
- Support in the segregation program at source and collection of solid waste to a local government.

In 2023, within the framework of the First Business Meeting of Business Leaders in Sustainability and Environmental Empathy and for compliance with the APL agreement, we obtained the “Peru Limpio” recognition, reaffirming our commitment to circularity.
